Entry Fees – June 2021 series

In light of the Government's decision to cancel examinations this summer, we are pleased to be able to make a reduction of 42% to our published entry fees for impacted qualifications.

In recognition of additional work undertaken by schools and colleges to support Centre Determined Grades, the Welsh Government has also committed to providing additional support to centres in Wales. To simplify access to the additional funding from Welsh Government, this will be administered through the invoicing process – meaning that invoices represent an overall discount of 50%.

Fees that have been charged:

Linear schemes (Eduqas GCSE and GCE, some WJEC GCSE, Level 2 Additional Maths, Entry Level, Extended Project and Foundation Art and Design).

- entries have been charged as normal against the qualification at the reduced fee.

Unitised schemes (WJEC GCSE and GCE, Level 1 Latin, Level 1/2 Vocational Awards and Certificates, Applied Level 3 Certificates and Diplomas, WBQ and HSCC qualifications (except Core)).

- entries for candidates certificating were made for the cashin code only and the reduced fee has been charged against the cashin code.

- where unit entries were permitted, they have been charged at the reduced unit fee.

- Applied Level 3 candidates who have been entered for Certificate units and Certificate cashin will have been charged the reduced cashin or unit fees but will appear as a credit for the units.

- if applicable GCSE, Level 1/2, Level 3 and WBQ units entered and charged for in series prior to June 2021 that would have contributed to the certification in June 2021 will appear as credits. This was not necessary for GCE as the fees for the A level are just for the A2 units.

- candidates who have previously paid for all units and have received an overall grade previously are deemed as resitting so will be charged for one unit only (as this is the least they would have to reenter). As candidates are being charged against the cashin the invoice will show a credit for the other units.

Other qualifications:

Entry Pathways, Gwaith Cymraeg and Language Pathways.

- entries have been charged as normal against the units at the reduced fee.

HSCC Core.

- entries have been charged as normal at the published fee.

Fees that have not been charged

We have not applied any entry fees where:

- a candidate has been entered and subsequently withdrawn after the amendment deadline. *

- a JNP non-grade outcome has been submitted by the centre. *
- a tier or option that has been amended after the amendment deadline.
- * Credits will be issued for these at a later date.

Process

Entry fees invoices have been run for entries submitted by the amendment deadline of 22nd April (12th May for Level 1/2 and Level 3).

Any changes relating to entries processed between the amendment deadline and 20th July will be issued on late fees invoices after the 20th July.

Please note that any credit adjustments have been broken down by individual candidate and, where applicable, unit entry. In order to provide full clarity around the credit adjustments made, invoices may show multiple credit lines per candidate.

We will be issuing invoices to centres electronically from the end of June, and we would be grateful for the settlement of invoices as soon as possible. Please note that no hard copies will be provided by post.
