#### 1. Latest news

#### New specification

The new Level 1/2 Vocational Award in Retail Business specification is available for centres to start teaching in September 2022. The first NEA submission will be in Summer 2023 and will be online submission once again. First award will take place in 2024.

The briefs will be available on the secure site in September each year. These briefs will change each year.

It is confirmed that the new specification is on the performance tables for 2024.

The textbook for the new specification is anticipated to be available to purchase in September 2022.

#### Legacy specification

For centres completing the legacy specification, please note that the final award will be in Summer 2023. There will be an opportunity for resits only in January 2024 for the external unit.

For the final NEA submission in 2023, candidates must complete the JJ's scenario for unit 3.
